Research to include: examination of voting records, profile (what they state they accomplished), where they stand on the issues we feel are important to our members, any other relevant information uncovered by the members involved.

### **Issues and Concerns**

What is your position on Medicare? Do you support it in its present form? If not, what would you change – increase benefits, increase premiums or co-pays, replace it with a voucher system?

What is your position and do you support allowing Medicare to negotiate prescription drug prices?

Do you support social Security in its present form? If not, what would you change? Would you support privatization? Raising the age at which people would be eligible for benefits? To what age? Increasing benefits? How would you propose paying for it?

Do you support increasing the cap on Social Security withholding tax as a means of insuring the solvency and continued viability of the system?

What is your position on the following issues related to gun control: Do you support raising the age of gun purchases to 21 or older? Do you support establishing stringent universal background checks for all gun sales? Do you support prohibiting people on Federal Watch Lists from being able to purchase guns?
